**Initial Director**

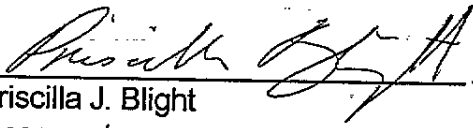
The corporation shall have one (1) director who shall manage the corporation. The initial director shall be Priscilla J. Blight.

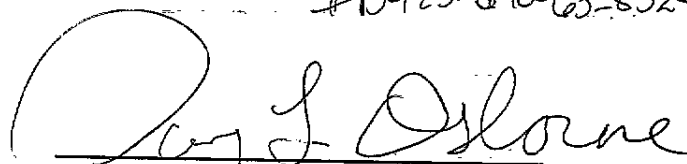
