I was very surprised to learn recently, upon applying for the fictitious name renewal, that my corporation was not active. This is my first corporation and I really did not receive, nor did I realize that it was time for, the Annual Renewals all these years. The most likely reason that I did not receive your correspondence was because the last time I paid the \$150 and sent the form2002 UBR, I also changed the mailing address to my physical office address of 1402 E. Las Olas Boulevard.

In retrospect, I realize that there was a problem with my mail delivery because the prior business tenant located at my 1402 address was a "Mailbags" office in the business of collecting mail for hundreds of customers with post office boxes at my same address, before Paragon Properties was there. Until the Mailbags business could get ALL their customers to input change of addresses, and depending on the particular mailman of the day and his/her familiarity with the situation and opinion of what to do, Paragon waseither getting everyone's mail by mistake or, more often, the post office was redirecting ALL the mail including Paragon's, somewhere else, either to Mailbags or back to the sender, and Mailbags was not always forwarding my mail back to me when they got it. It was a real mess for quite a while, with no real way to solve it other than by the passing of time.

I would never just not pay or avoid the payment of any renewal fee. I pay so many different fees all the time to stay in business. I am a good payer with everything.
