**ARTICLES OF INCORPORATION**  
**of**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, for the purpose of forming a corporation under The Florida General Corporation Act, Florida Statutes Section 607, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

This corporation shall be known as KIT'N KABOODLE, INC.

**ARTICLE II - DURATION**

The term of existence of this corporation is perpetual.

**ARTICLE III - PURPOSE**

This corporation may engage in, or transact the business of, the sale of gifts and greeting cards and all business activities related thereto, as well as any and all other lawful business and/or activities for which corporations may be incorporated under the laws of the United States of America, The Florida General Corporation Act, the State of Florida, and/or any other state, country, territory, or nation.

**ARTICLE IV - CAPITAL STOCK**

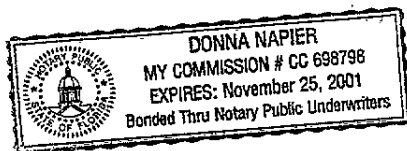
