ARTICLES OF INCORPORATION

We the undersigned natural persons of the age of twenty - one years or more, acting as incorporators of a corporation under the revised Model Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article 1. The name of said corporation shall be: I DECLARE, INC.
