# ARTICLES OF INCORPORATION

OF

## SPEAK UP, INC.

The undersigned subscriber of these Articles of Incorporation, natural person competent

to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I

#### Name

The name of this Corporation is SPEAK UP, INC.

# ARTICLE II

## Nature of Business

The general nature of the business to be transacted by this corporation is any lawful business.

# ARTICLE III

#### Share of Stock

The total number of shares of stock which the corporation shall have the authority to issue is One Thousand (1,000) Shares, all of which shares shall have a par value of One Dollar (\$1.00) and shall have equal rights, privileges and voting power, unless other wise agreed upon.

The shares of stock in this corporation may be paid for by property, labor, or services at a just valuation, to be fixed by the Board of Directors. Any and all shares so issued shall be deemed fully paid and non-assessable and the holder of such shares shall not be liable to the corporation or to its creditors in respect thereto.

## ARTICLE IV

# Term of Existence

This corporation is to exist perpetually.

## ARTICLE V

#### Address

The principal office of this Corporation is to be located at 5855 East Irlo Bronson Highway, St. Cloud, Florida. The Board of directors may from time to time move the principal office to any other address in Florida.

#### ARTICLE VI

## Directors

This corporation shall have one (1) Director initially. The number of Directors may be increased from time to time by the By-Laws adopted by the Stockholders but shall never be less than one(1).

## ARTICLE VII

## Initial Directors and Officers

The name and address of the members of the first Board of Directors and Officers are as follows:

The persons named as initial directors shall hold office for the first year of existence of this Corporation or until his successor is elected or appointed and has qualified, whichever occurs first.

## Amendments

## ARTICLE XI

## Restrictions on Sale or Transfer of Stock

The Corporation and/or shareholders of the corporation may enter into any agreement restricting the sale or transfer of shares of stock in this Corporation which is authorized under the laws of Florida. The By-Laws of the Corporation may contain any restrictions on the sale or transfer of shares of stock in this Corporation which are authorized under the laws of Florida.

#### ARTICLE XII

## Indemnification

Each Director and Officer of the Corporation, whether or not then in office, shall be indemnified by the Corporation against all costs and expenses reasonably incurred by him in connection with or arising out of any claim, demand, action, suit or proceedings in which he may be involved or to which he may be a party by reason of his being or having been made a director of officer of the corporation (said expenses to include attorneys' fees and costs or reasonable settlements made with a view of curtailment of costs of litigation), except in relation to matters as to which he finally shall be adjudged in any such action, suitor proceedings, to have been derelict in the performance of his duty, as such officer or director. Such right of indemnification shall be exclusive of any rights to which a director or officer may be entitled under any regulations, agreements, vote of stockholders, or to which he may be entitled as a matter of law, and the rights of indemnification shall inure to the benefit of the heirs, executors and administrators of any such director or officer.
