ARTICLES OF INCORPORATION
OF

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

NAME

The Corporation name is ICONNECT TELECOMMUNICATIONS, INC.

ARTICLE TWO

DURATION

The duration of the Corporation is perpetual.





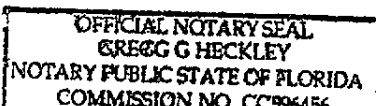
