ARTICLE I: NAME

The name of the corporation is: E.M.C. Jewelers, Inc.



ARTICLE X: AMENDMENT



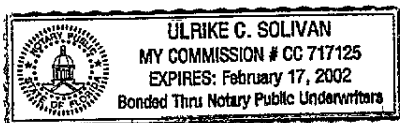
