# Articles of Incorporation

Article 1: Name

The name of the Corporation will be JESSIE LOWDER, INC.

Article 2: Purpose of Corporation

This Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

#### Article 8: Preemptive Rights
