OF

ARTICLE I. CORPORATE NAME

The name of this corporation is Escambia Santa Rosa Building & Remodeling, Inc.

ARTICLE IX. AMENDMENT

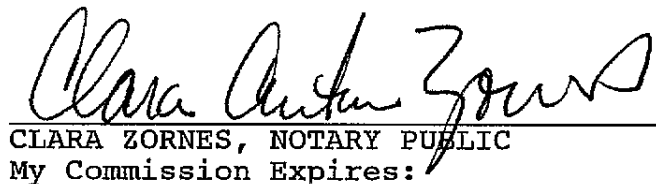

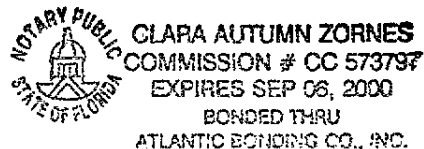
