

The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of this corporation is JEFF SMITH AUTOMOTIVE GROUP, INC.

**ARTICLE II
PURPOSE**

This corporation is organized for the purpose of automotive purchasing and sales, wholesale and retail and all other related activities permitted under the laws of the State of Florida and the United States of America.

**ARTICLE III
CAPITAL STOCK**

This corporation is authorized to issue One Thousand (1,000) shares of \$1.00 par value common stock.




