The undersigned, desiring to form a professional corporation for the practice of law, in accordance with Chapter 607, Corporations, and/or Chapter 621, Professional Service Corporations, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE  
NAME**

**ARTICLE TWO  
PRINCIPAL OFFICE**

The place in the State of Florida where the corporation's principal office is to be located is 1322 6<sup>th</sup> Avenue West, City of Bradenton, County of Manatee.

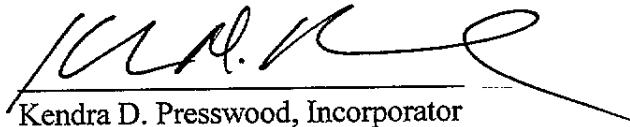

DURATION**

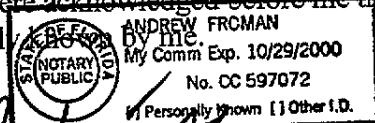
