ARTICLES OF INCORPORATION

OF

COMMERCIAL LAND TRUST INC



The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation shall be:

ARTICLE II

PURPOSES

The purposes for which the corporation is formed and the business and objects to e carried on and promoted by it are as follows:
