

ARTICLE 1 - NAME

The name of this Corporation is STAR SUPPORT, INC.

ARTICLE 2 - DURATION

This Corporation shall have a perpetual existence.

ARTICLE 3 - PURPOSE

The purpose of this Corporation is to engage in any lawful enterprise as permitted by the laws of the State of Florida, to wit: Chapter 607 F.S.

ARTICLE 4 - STOCK


