#### ARTICLES OF INCORPORATION

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

#### ARTICLE I

#### <u>Name</u>

The name of this corporation shall be:

#### ARTICLE II

#### **Business and Purposes**

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the General Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

The specific purpose for which this corporation is organized is the practice of general medicine.

# Capital Stock

#### **ARTICLE V**

# Registered Office and Registered Agent

The initial principal registered office of this corporation shall be located AT 8605 N. 40<sup>TH</sup> Street Tampa, Florida, 33604, and the initial registered agent of this corporation at such office shall be Jack Zichlin. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.

#### ARTICLE VI

# -Board of Directors

The Board of Directors of this corporation shall consist of one or more(1) members. The business and affairs of this corporation shall be managed by the Board of Directors, which may exercise all such powers of this corporation and do all such lawful acts and things as are not by law directed or required to be exercised or done only by the stockholders.
