




Dear Sir or Madam:

We are returning our originally filed corporate annual reports for our entities, Marathon Technical Associates, Inc. (FEI# 59-3226379), Marathon International Associates, Inc. (FEI# 59-3312658), Marathon Electronics, Inc. (FEI# 59-3576142), SWI, Inc. (FEI# 59-3598627), and SWIG, Inc. (FEI# 59-3589123) along with our letter originally attached to these returns requesting that the late filing penalties be abated due to the fact that we never received the first notice.

After receiving your letter dated August 1, 2003, we contacted an auditor at the Division of Corporations who suggested that our letter requesting waiver of the penalty may have been detached from the corporate annual report. She suggested that we resubmit our letter requesting waiver of the penalty.
