ARTICLES OF INCORPORATION

OF

Structured Systems, Incorporated

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the Corporation shall be Structured Systems, Incorporated

ARTICLE II NATURE OF BUSINESS

This Corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 5,000 shares of common stock without par value, all of one class. All stock is common stock having equal voting powers. There are no preferences, conversion rights, or special restrictions, limitations, or qualifications.

ARTICLE IV ADDRESS
