The undersigned, being of legal age and desiring to form a corporation (hereinafter referred to as /D/the "Corporation") pursuant to the provisions of the Florida Business Corporation Act, as amended (such Act, as amended from time to time, is hereinafter referred to as the "Act"), executes the following Article of Incorporation.

ARTICLE 1

Name:
