ARTICLES OF INCORPORATION OF

**ARTICLE I. CORPORATE NAME.**

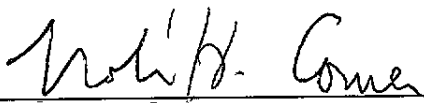
