ARTICLE I, "Name" is amended to read as follows:

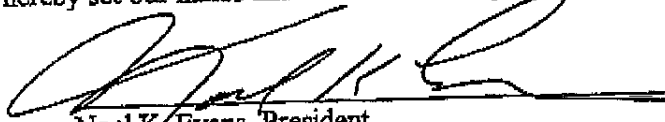
The name of the corporation is NOEL EVANS, P.A.

ARTICLE II, "Principal Office and Initial Registered Agent" is amended to read as follows:

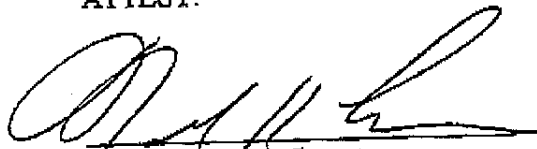
The address of the corporation's principal office and the address of the registered agent, Noel K. Evans, is 10121 Woodsong Way, Tampa, Florida 33618.
