As the Registered Agent of the above mentioned client, I am requesting a waiver of the \$400.00 late fee assessed. Our office at 3055 Cardinal Drive, Suite 303, was destroyed by Hurricane Frances in 2004 and we moved to a temporary location at 1515 Indian River Boulevard, Suite A245, Vero Beach, FL 32960. Several post offices in Vero Beach were also destroyed by Hurricanes Frances and Jeanne. Although our mail was supposed to be forwarded, most of it was not forwarded due to the post office situation.
