**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator of these Articles of Incorporation does hereby form a corporation pursuant to the Florida General Corporation Act and does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE  
NAME AND PRINCIPAL OFFICE**

The name of this Corporation is Nasr's Auto Sales Inc. The Corporation's principal office is located at 38652 U.S. Highway North, Tarpon Springs, Florida 34689.

**ARTICLE TWO  
DURATION**

The Corporation is to exist perpetually.

**ARTICLE THREE  
PURPOSE**

This Corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act, including the provision of sales and services.

**ARTICLE FOUR  
CAPITAL STOCK**


