The undersigned, for the purpose of forming a corporation under Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is ANDREA N. HASS, M.D., P.A.

ARTICLE II - DURATION

This corporation shall exist in perpetuity.

ARTICLE III - PURPOSE

This professional association is organized to practice various forms of Ophthalmology surgery, all other medical services and all other things legal in the State of Florida.

ARTICLE IV - CAPITAL STOCK

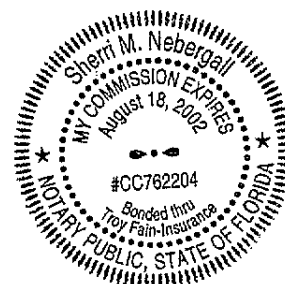

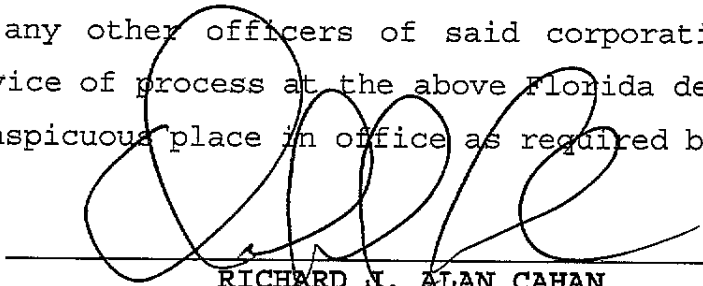
