


**ARTICLE VIII

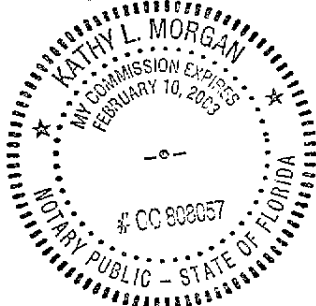


