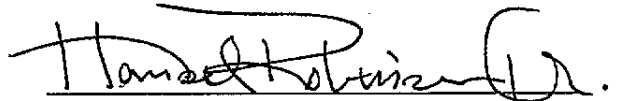
**ARTICLE IX
