The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida

#### ARTICLE I – NAME

The name of this corporation is ASSASSIN PEST MANAGEMENT, INC.
