

In compliance with the requirements of the Florida Business Corporation Act, Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Digital Community Networks, Inc.

ARTICLE II

The existence of the Corporation shall begin on the date its Articles of Incorporation are filed with the Department of State for the State of Florida and its existence shall be perpetual.




