ARTICLE I. - NAME

The name of this corporation is **J. C. M. & M. ENDEAVORS, INC.**

ARTICLE VIII. - INDEMNITY OF OFFICERS & DIRECTORS


The corporation shall indemnify any officer or director to the full extent permitted by law.
