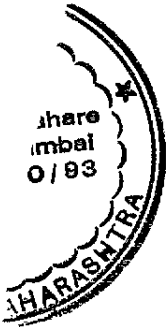
ARTICLE IX. INDEMNITY

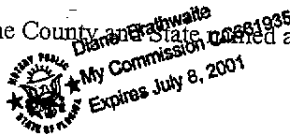

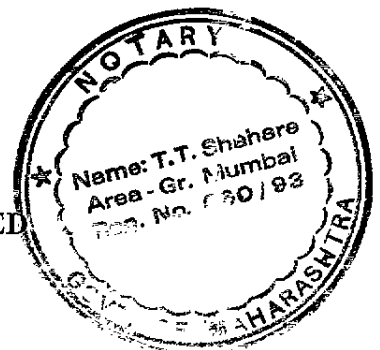
