I am enclosing Stevemar, Inc.'s. 2001 Annual Report, together with a check for \$150 (in the mail copy of this letter), and supporting correspondence. Please waive the late fee.

As you will note from the enclosed Public Inquiry, Stevemar's name was erroneously given to another corporation—Ramirez Carpentry Corporation—by your computer in 2000. Accordingly, Mr. Ramirez was apparently sent Stevemar's 2001 Annual Report.

I sent in the attached, filled-in-from-a-blank, 2001 Annual Report, which arrived in your office on May 1, 2001. Stevemar's \$150 Check also arrived in your office a day or two earlier. (By April 30, 2001, it was impossible for us to get the check and the Annual Report together.)
