

ARTICLES OF INCORPORATION
OF

The undersigned, as incorporator, hereby executes these Articles of Incorporation for the purpose of becoming incorporated under Chapter 607 of the Florida Statutes, as amended, as a for-profit corporation under the laws of the State of Florida and certifies as follows:

ARTICLE I. The name of the corporation is Data Systems of the Keys, Inc. (the "Corporation").

ARTICLE II. The Corporation shall have a perpetual existence.

ARTICLE III. The Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be organized under the General Corporation Act of the State of Florida, whether granted by specific statutory authority or by construction of law.

ARTICLE IV. The aggregate number of share which the Corporation shall have authority to issue is 1,000 shares, \$.01 par value per share.

ARTICLE V. The street address of the initial registered office and the principal office of the Corporation is 127 Tequesta Street, Tavernier, Florida, 33070.

ARTICLE VII. The initial Board of Directors shall consist of two persons, whose names and addresses are as follows:




