ARTICLES OF INCORPORATION

OF

HAYS MOBILE HOME SKIRTING, INC.

The undersigned, for the purpose of forming a Corporation under Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE--NAME

The name of the Corporation is HAYS MOBILE HOME SKIRTING, INC.

ARTICLE TWO--DURATION

The duration of the Corporation is perpetual. Corporate existence will commence at the time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE THREE--PURPOSE

The Corporation is a corporation for profit and is organized for the following purposes:

1. To install stucco skirting onto mobile homes.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing, or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR--SHARES

The aggregate number of shares which the Corporation is authorized to issue is sixty (60) shares; such shares shall be of a single class, all of which shall be common stock, and

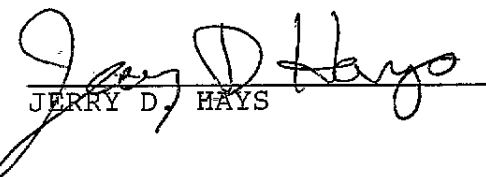

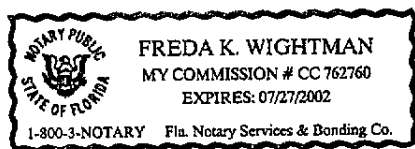
