ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is Jerger Communications, Inc.

ARTICLE II

The existence of the Corporation shall begin on August 15, 1999.

ARTICLE III

The street address of the principal office of the Corporation is 556 John's Pass Avenue, Madeira Beach, FL 33708.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 10,000, par value \$ 1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The purpose of Jerger Communications, Inc. shall be for the specific purpose of rendering professional services including providing lobbying, governmental affairs, public relations, and any other lawful business in the State of Florida or otherwise.

ARTICLE VI

The initial street address of the Corporation's registered office is 556 John's Pass Avenue, Madeira Beach, FL 33708. The initial registered agent for the Corporation at that address is Nicole B. Jerger.

ARTICLE VII

The initial board of directors shall consist of one (1) member(s). This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The names and addresses of the persons who will serve on the initial board of directors are:
