ARTICLES OF INCORPORATION OF WHITE STAR LINE INTERNATIONAL, INC.

PARTITION OF THE PARTIT

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 – NAME

The name of the Corporation is White Star Line International, Inc., (hereinafter, "Corporation").

ARTICLE 2 – PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.

<u>ARTICLE 3 – PRINCIPAL OFFICE</u>
