We, the undersigned subscribers, hereby come before the state of Florida for the purpose of becoming a corporation. This corporation is organized by and under the provisions of For-Profit Corporation's statutes of the State of Florida.

ARTICLE I

NAME and ADDRESS

GENERAL NATURE OF BUSINESS

This corporation may engage in intrastate and interstate transportation by motor carrier that includes heavy- duty tractors and trailers for hire, flat rate contract, and commission. This corporation may also engage in other businesses that are allied to the transportation industry to include transportation brokering; storage and freight forwarding; and product sales. The corporation may also conduct any other activities or businesses permitted under the laws of the state of Florida.

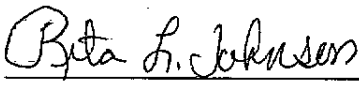

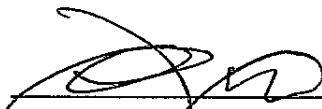
