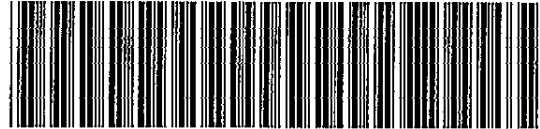


On January 12, 2003 we submitted our form 607-1401, Article of Dissolution for Success-Unlimited.net, Inc.


