# ARTICLES OF INCORPORATION

## Pro Auto Repair Inc.

Article 1. The name of this corporation shall be Pro Auto Repair Inc., and the street address of the initial principal office of this corporation shall be 19 Hardee Street, LaBelle, FL 33935.

Article 2. This corporation shall have perpetual existence.

Article 3. This corporation is organized for the purpose of any and all lawful business.

Article 4. This corporation is authorized to issue one thousand (1000) shares of \$1.00 par value common stock.

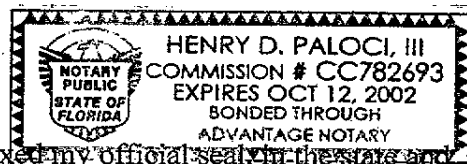
