

# ARTICLES OF INCORPORATION OF MAXDOG MEDIA, INC.

#### ARTICLE I - NAME

The name of this corporation is Maxdoq Media, Inc.

## ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

## ARTICLE III - CAPITAL STOCK
