

THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation is CERTUS INVESTMENTS, INC.

ARTICLE II

PRINCIPAL OFFICE

The address of the principal office and the mailing address of this Corporation is 1108 Wilkinson Street, Orlando, Florida 32803.

ARTICLE III

DURATION

This Corporation shall have perpetual existence commencing on the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE IV

PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE V

CAPITAL STOCK

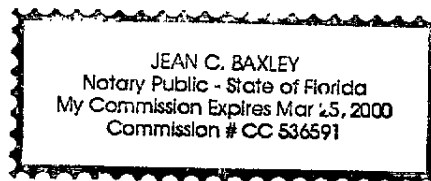
