ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE The undersigned subscriber to these Articles of Incorporation, being a natural person and competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I. - NAME

Acrom Properties, Inc. is the name of this Corporation.

ARTICLE II. - PRINCIPAL OFFICE
