ARTICLES OF INCORPORATION OF GRACE BAY DEVELOPMENT, INC.

<u> ARTICLE I - NAME</u>

The name of this corporation is:

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation
