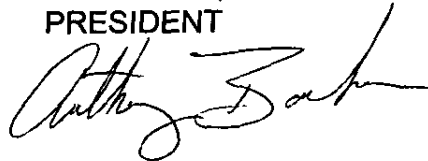
Dear Ms Harris,
