The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

# ARTICLE I

NAME:

The name of this corporation is: UNIPLEX TELECOM ECUADOR CORP.

# **ARTICLE II**

#### **NATURE OF BUSINESS:**

The general nature of business to be transacted by this corporation is: To engage in any activity of business permitted under the Laws of the United States of America and the State of Florida.

### ARTICLE III

#### **CAPITAL STOCK:**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED shares at no par value.

## ARTICLE IV

## **INITIAL CAPITAL:**
