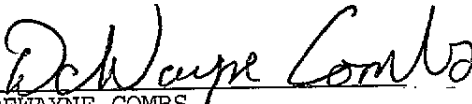

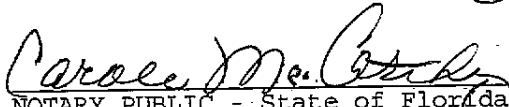

BY THESE ARTICLE OF INCORPORATION, the undersigned acting as incorporator pursuant to Florida General Corporation Act, forms a corporation for profit.

### ARTICLE I.

The name of the corporation shall be Techno-Wizards, Inc.

### ARTICLE II.

This corporation shall have perpetual existence, unless sooner dissolved according to law.

### ARTICLE III.

This corporation is to transact all lawful businesses for which corporation may be incorporated under Chapter 607, Florida Statutes.

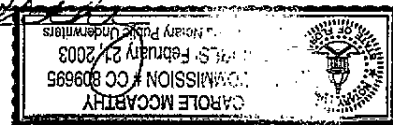
