ARTICLES of INCORPORATION

OF

AEROSPACE QUALITY SERVICES, INC.



The undersigned Incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

AEROSPACE QUALITY SERVICES, INC.

The principal place of business of this corporation shall be 14500 SW 161st Street, Miami, Florida 33177; and the mailing address shall be the same.

ARTICLE II. NATURE of BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having \$.10 par value per share.
