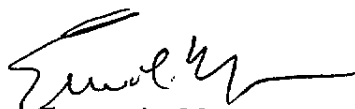

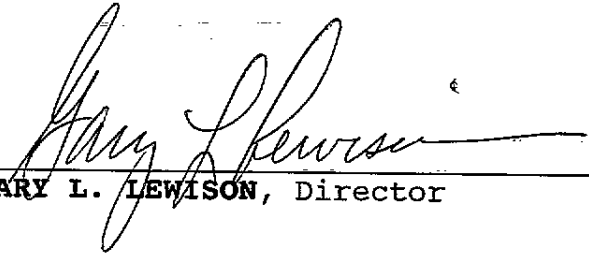
ARTICLE IV - UNANIMOUS CONSENT
