## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF HOLISTIC DERMACEUTICALS, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Articles of Incorporation are hereby amended as follows:
