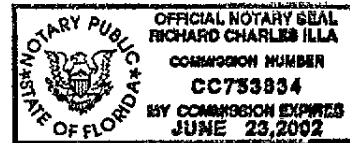
ARTICLE I - NAME

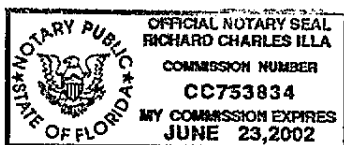
