

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

**ARTICLE I.**

Name

The name of this corporation shall be West Coast Soccer, Inc.

Nature of Business

Stock

**Term of Corporate Existence**

This Corporation shall exist perpetually, unless dissolved according to law.

**ARTICLE VII.**

**Address of Registered Office and Registered Agent**


