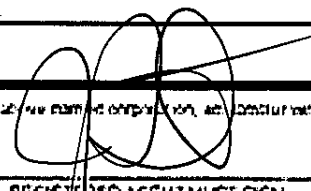

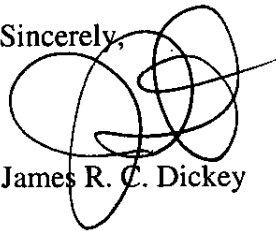
Ladies/Gentlemen:
