The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE I. NAME.

The name of this Corporation shall be King Drywall of S.W. Florida, Inc.

## ARTICLE II. COMMENCEMENT & DURATION.

The existence of the Corporation will commence upon filing as provided by the laws of the State of Florida, and will continue thereafter perpetually.

## ARTICLE III. PRINCIPAL OFFICE.

#### ARTICLE IV. NATURE OF BUSINESS.
